Course tuition fees

These are the full tuition fees for each course delivered online by ICQA. You can also enrol in individual units of competency or a skill set drawn from these qualifications — ask us for a quote.

Payment arrangements

ICQA offers flexible payment plans for learners who enrol and pay as individuals. We spread your tuition across your course and protect your money: we never hold more than \$1,500 of your fees ahead of the training we have actually delivered. Here is how the plan works for each course.

Each instalment is about eight weeks apart, and your course is fully paid by Week 44, before you finish.

Paying through an employer, company or HRDC?

If your training is being paid for by an employer, a company, or an HRD Corp (HRDC) arrangement, we invoice that organisation for the full course fee up front, under a written service agreement. The \$1,500 prepaid limit applies to individual learners paying for themselves; it does not apply to these employer-funded arrangements.

Your money is protected: at no point in your course does ICQA hold more than \$1,500 of your tuition fees ahead of the training we have actually delivered. Your instalments are scheduled so this limit is always met.

Non-tuition fees

These fees apply only if and when you use the service they relate to. They are not part of your tuition fee.

How to pay

ICQA accepts the following payment methods:

- Credit card

Payment details are provided on your learner invoice.

Discounts and concessions

Depending on your circumstances, you may be eligible for:

- Employer-sponsored enrolment
- Group enrolment discounts
- Continuing learner discounts

Any discount or concession that applies to you will be documented in your Written Agreement.

Refunds

Whether you are eligible for a refund is decided in line with the ICQA Student Fees and Refunds Policy. To request a refund, complete the Refund Request Form and send it to us.

GST

Most vocational education and training services are GST-free under section 38-85 of the GST Act. GST may apply to some non-tuition administrative fees.

Additional costs for work placement

If your course includes a work placement (for example, the Certificate III in Individual Support), you may need to obtain the following before you can attend your placement:

- National Police Check
- NDIS Worker Screening Check
- Working With Children Check
- Vaccinations required by your host organisation

These costs are not included in your tuition fee. You pay them directly to the issuing authority.
